#### **New Trauma Recovery Center Grants Awarded**

CalVCB approved \$21.8 million in grant money to fund 15 Trauma Recovery Centers (TRCs) for the next two fiscal years. Funding begins on July 1, 2023, and concludes on June 30, 2025.

Of the 15 TRCs awarded grants, eight are existing CalVCB-funded TRCs, three are newly funded TRCs, and one is a former CalVCB-funded TRC.

They will receive funding ranging from \$531,914.75 to \$2.2 million. The funding amount differs based on application scores and the requested dollar amount.

During the current fiscal year, CalVCB funds 18 TRCs statewide.

### **Information Security Verification**

Victim specialists and all District Attorney's Office staff with access to CalVCB computer systems are required to complete information security and privacy training annually. The training must include social engineering and phishing, privacy and password protection, browsing safety, and ransomware.

All new specialists and District Attorney's Office staff with access to CalVCB computer systems must complete the training within 30 days from the date of hire.

Any training costs incurred will be the responsibility of that office.

In case of noncompliance, CalVCB may suspend access to CalVCB computer systems, including Cares2, until compliance is confirmed.

A section on security training requirements has been added to the annual confidentiality statement. The updated form is being sent to all offices and must be returned no later than Friday, April 28, 2023.

### **Vehicle Insurance Policy**

Effective Dec. 1, 2022, CalVCB policy requires that an automobile-related claim be filed with any available vehicle insurance company, even if the applicant was a pedestrian or passenger. This includes the applicant's own vehicle insurance.

Additionally, filing a claim is required regardless of whether the crime resulted in a traffic accident.

While rare, vehicle insurance may be able to compensate victims in these situations. Therefore, it cannot be assumed that a reimbursement source is not available

## **Keeping Cares2 Up to Date**

Reminder: As you add or lose advocates on your team, email **infoadvocate@victims.ca.gov** with the changes. We will update our internal contact list and revise roles within Cares2.

Also, remember to log into your Cares2 account at least once every 90 days or it will automatically deactivate. To have it reactivated, you must email **infoadvocate@victims.ca.gov**.

### **Did You Know?**

Under most circumstances, only a direct victim who suffers a period of disability due to a qualifying crime-related injury is eligible for income loss. However, parents or legal guardians of a victim, who at the time of the crime was under the age of 18 years and is hospitalized or dies as the direct result of a qualifying crime, may be eligible for up to 30 days of income loss. For all applications submitted on or after Jan. 1, 2003, compensation is to be based on the law in effect at the time the application was submitted. (Gov. Code, § 13959(d))

When considering reimbursement for a victim, the victim would be eligible for benefits in place at the time the application was filed.

If a California resident is victimized in another state and they apply with that state's compensation program, they may use benefits from California's compensation program once the benefits from the out-of-state program are exhausted. If the victim exhausts the benefit or is denied a benefit by the out-of-state program, CalVCB must receive documentation to verify the exhausted or denied benefit.
